# Conditions of Entry – Ag-Art Wear Competition

These conditions of entry apply to all competition entrants.

1. All entrants must complete the official 2 page entry form which includes;

- Full contact details of the entrant including telephone number and entrants background,
- A description stating the materials used to create the garment,
- The inspiration for the design of the garment,
- A list of individual garment pieces/accessories,
- Full wearing/dressing instructions including colour photographs of front and back views of the garment,

Entry to the competition is **FREE**.

2. There are four sections: (1) **Under 18years Ag-Art Wear** (2) **18years and over Ag-Art Wear** (3) **Under 18years Up-cycled Wear** and (4) **18years and over Up-cycled Wear**. Each creation may only be entered in one section and must not have won an award in any other Field Days/Agricultural Show “Ag-Art Wear”® or similar competition. The committee reserves the right to transfer entries to a more appropriate section if considered necessary. Entrants will be notified if this is the case.
3. The person/group named on the entry form must have created the garment. A maximum of 2 entries per designer will be accepted. When promoting this event, the Riverland Field Days Inc. holds the exclusive rights for all advertising and photos relevant to the Ag-Art Wear Competition.
4. **AG-ART WEAR GARMENT:** The creation and its accessories are to be **made from material of an agricultural and/or horticultural nature as produced or found on a farm or block**, however buttons, zips and such items may be used without penalty. Use of non-agricultural products such as household items, commercial dress fabric, hats, shoes etc. is allowed, however points will be deducted. Materials may be of new or used condition.
5. **UP-CYCLED WEAR GARMENT:** The creation and its accessories are to be **made from products of a recycled/used nature**. All materials/products used need not be of an agricultural/horticultural nature but must have served their purpose in their intended way and then reused to be given new life in the form of a piece of wearable art. You are only limited by your imagination and with the use of found materials/products; eg. milk cartons, coffee pods, tin cans, plastic bottles, packaging material etc. Points will be deducted for the use of new materials/products.
6. All garments to be from size 10 – 14 (adult women’s and equivalent men’s). Any garments outside these sizes will not be accepted.
7. The garment must allow free body movement and not injure, scratch or be of a hindrance to the wearer. It must be of a weight that can be comfortably worn and carried. Every garment must be able to pass through a standard doorway whilst being worn.
8. The creation must be durable enough to be worn at least 4 times under fashion parade conditions. All models are arranged by the Ag Art Coordinator.
9. Judging will be based on the imagination of the creator, the appearance, and the use of materials. The creation need not be practical, but rather entertaining and/or artistic.
  - a. **G-ART WEAR :** Garment to be made from new or used **agricultural and/or horticultural material/products**.
  - b. **UP-CYCLED WEAR:** Garment to be made from only **recycled/used materials/products**, of any nature.
10. Judging is on visual inspection. Judges do not examine the finish or seams of garments.
11. The judge’s decision will be final and no correspondence will be entered into.
12. Riverland Field Days “Ag-Art Wear” Competition judging will be held at the Riverland Field Day and the winners to be announced at the final parade on Saturday 16<sup>th</sup> September. All designers are encouraged to attend the award presentation ceremony at the conclusion of the Saturday afternoon parade.
13. It is the responsibility of the entrant to **arrange delivery of the garment** to the Ag-Art Wear Coordinator Sarah Plush by **Friday 8<sup>th</sup> September 2023**. Any garments delivered after Friday 8<sup>th</sup> September 2023 will not be eligible to compete unless other arrangements are made.
14. Collection of garments after the event is between 4pm and 5pm on Saturday 16<sup>th</sup> September 2023 and is the responsibility of the entrants. If the garment is not collected it becomes the property of the Ag-Art Wear Competition, unless other arrangements are made with the Ag-Art Wear Coordinator. The organizers will not be responsible for any damage or loss of an entry.
15. The Committee reserves the right to amend the Conditions of Entry if deemed necessary prior to the event. Notification will be given as soon as possible following the amendment.
16. Entrants failing to comply with any of the above conditions may be excluded from the competition.
16. Entrants will be issued with a complimentary one day pass to the Riverland Field Days Event.
18. Cash prize pool valued at \$1000.
